# Overview

Bennett's Beans is focused on the supply of premium Canadian dry beans through an operating model designed to support product consistency, practical documentation, and reliable execution across sourcing, processing, and shipment planning.

We work through established grower relationships and coordinated supply programs in Canada, allowing us to align product availability with crop region, customer requirements, and destination-market needs. Our role is not limited to product sourcing alone; we also coordinate the practical steps required to move product from farm-origin supply into customer-ready processing and shipment programs.

# Sourcing & Supply Coordination

Our dry bean programs are built around Canadian agricultural supply networks and long-term grower relationships. Product is sourced according to variety, crop conditions, market requirements, and the intended end use of the buyer. This gives us the flexibility to support customers seeking Canadian-origin beans with commercially clear coordination and export-oriented planning.

Because dry bean orders vary significantly from one customer to another, supply planning is handled with attention to origin, cleaning requirements, packaging needs, logistics planning, and documentation support. Each order may involve different operational requirements depending on bean type, destination, packaging format, timing, and customer expectations for finished product presentation.

To support quality consistency, handling efficiency, and shipment flexibility, cleaning, sorting, grading, and packing are carried out through selected third-party facilities in Canada. Facilities are chosen according to crop location, processing needs, packaging requirements, program timing, and logistical efficiency.

This structure allows Bennett's Beans to match the processing arrangement to the actual needs of the order. It also supports practical coordination between sourcing location, cleaning requirements, packing format, and shipment planning, without implying ownership of the facilities used.

# Food Safety Approach

Food safety is an important part of how supply programs are structured and reviewed. Because cleaning, sorting, and packing are performed through selected third-party facilities, the food safety framework applicable to a given order depends on the facility used, the scope of processing performed, and the nature of the supply program.

Depending on the confirmed arrangement, selected facilities may operate under recognized food safety and quality management systems such as HACCP, GMP, preventive control programs, customer-specific food safety protocols, or other industry-standard systems where applicable. Bennett's Beans therefore does not present all programs as though they are processed under one identical facility certification structure in every case.

Instead, documentation and food safety representations are aligned with the actual product lot, the actual facility arrangement, and the actual shipment program under execution. This supports a more accurate and operationally defensible representation to buyers.

# Documentation Availability

Relevant quality, processing, and shipment-related documentation may be available upon request, depending on the product, lot, processing arrangement, destination, and commercial program. The availability of specific documents may vary according to the stage of the transaction and whether the request relates to quotation, confirmed order, or shipment execution.

DOCUMENT CATEGORY	TYPICAL AVAILABILITY / SCOPE
PRODUCT INFORMATION	Specification sheets, packaging details, format information, and applicable order-specific handling notes.
QUALITY SUPPORT	Lot-based quality information, plus product or loading photos where available.
FACILITY-RELATED DOCUMENTATION	Relevant food safety documents connected to the selected processing arrangement, where applicable and suitable for review.
SHIPMENT SUPPORT	Export-related commercial or shipment documents, plus third-party inspection/testing coordination when requested.

# HACCP & Facility Related Food Safety Documentation

When customers request food safety information such as HACCP-related documents, the relevant response depends on the confirmed processing structure used for the order. Where applicable, selected third-party facilities may operate under HACCP-based or equivalent systems, and supporting documentation may be shared in line with the selected arrangement and the level of information suitable for customer review.

This means food safety documentation is connected to the facility used for the order rather than represented as a universal certification held directly by Bennett's Beans for all programs. Our objective is to provide customers with practical, relevant, and accurate documentation support while ensuring that representations remain aligned with the real operating structure of the supply program.

## HOW TO POSITION SGS

Third-party inspection and testing services such as SGS or equivalent providers may be arranged upon request, subject to shipment timing, scope of work, service availability, and commercial agreement. These services are order-specific and should not be described as standing company certifications.

Packaging arrangements are determined according to customer requirements, product characteristics, and shipment format. Depending on the program, this may include bulk or bagged formats, export packing configurations, and container loading structures appropriate for the intended destination. Shipment support may also include coordination of commercial documentation and export documentation as applicable to the market and order stage. Not all buyers require the same cleaning level, packaging style, or documentation depth. Some customers prioritize price efficiency, while others require retail-ready presentation, inspection support, or added documentation detail. For that reason, Bennett's Beans approaches each supply program with a customer-specific view so that product type, market destination, documentation requirements, and shipment expectations are aligned with the confirmed order rather than treated as a generic commodity transaction.
